



Admissions Policy for Godstone Village Nursery for 2017/18

A child will be eligible for admission to Godstone Village School nursery class from the term after they turn 2 years old. Admission will be subject to an application being made and places being available.

We operate:

- Sessions of 2 and a half days per week, FEET¹ or FEE¹ 15 hours Universal entitlement (2 x 6 hour full days and 1 x 3 hour half day).
Children would either attend all day Monday, all day Tuesday and Wednesday morning, or Wednesday afternoon, all day Thursday and all day Friday.
- OR
- 5 full days (5 x 6 hour full days) with either FEE 15 hours Universal entitlement plus FEE 15 hours Extended entitlement (totalling 30 hours) or, FEE 15 hours Universal entitlement and an additional 15 hours funded by the parents/carers.

Parents/carers may pay for 30 hours at £195 per week or 15 hours at £97.50 for two year olds. An additional 15 hours can be purchased at £75 for three and four year olds.

The admission of Nursery children is delegated to the Governing Body of Godstone Village School. Parents wishing to apply for a place for initial entry must complete the application form and submit it directly to the school office. Admissions are only at the beginning of each school term.

When the Nursery is over-subscribed, the Governors will consider applications in accordance with the following criteria set out in priority order. Length of time on any waiting list will not be taken into account.

Where any of the following categories are oversubscribed applicants will be ranked according to the straight line distance that they live from the school with priority being given to children who live closest to the school.

Places for 3 and 4 year olds

a) Looked after and previously looked after children

Looked after and previously looked after children will receive top priority. Looked after children and previously looked after children will be considered to be:

- Children who are registered as being in the care of a Local Authority in accordance with Section 22 of the Children Act 1989(a) e.g. fostered or living in a children's home, at the time an application for Godstone Village school is made; and
- Children who have previously been in the care of a local authority, in accordance with section 22 of the Children Act 1989(a), and who have left care through adoption, a child arrangements order (in accordance with section 8 of the Children Act 1989 and as amended by the Children and families Act of 2014) or a special guardianship order (in accordance with Section 14A of the Children Act 1989).

Places will be allocated under this criterion when places are first offered at a school and the Local Authority may also ask the school to admit over their Published Admission Number at other times under this criterion.

b) Where there is a social or medical need for a place at that school

Occasionally there will be a very small number of children for whom exceptional social or medical circumstances will apply which will warrant a placement at a particular school. The exceptional social or medical circumstances might relate to either the child or the parent or carer. Supporting evidence from a professional is required such as a doctor and/or consultant for medical cases or a social worker, health visitor, housing officer, the police or probation officer for other social circumstances. This evidence must confirm the circumstances of the case and must set out why the child should attend Godstone Village School and why no other school could meet the child's needs.

Providing evidence does not guarantee that a child will be given priority and in each case a decision will be made based on the merits of the case and whether the evidence demonstrates that a place should be made at Godstone Village School above any other.

c) Children who will have a sibling at the school at the time of the child's admission

A sibling will be considered to be a brother or sister (that is, another child of the same parents, whether living at the same address or not), a half-brother or half-sister or a step-brother or step-sister or an adoptive or foster sibling, living as part of the same family unit at the same address.

d) Children who will turn 4 years old between 1 September 2017 and 31 August 2018 (this is to give priority to older children who will be due to transfer to Reception in the next academic year and hence only have one year left to attend nursery).

Children who will turn 3 years old between 1 September 2017 and 31 August 2018 (these children will be able to stay on in nursery for another year and will be due to start Reception in September 2018).

Places for 2 year olds

a) Children who are eligible for FEET, with oldest having priority

b) Looked after and previously looked after children

c) Where there is a social or medical need for a place at that school

d) Children who will have a sibling at the school at the time of the child's admission

e) Age (oldest will have priority)

Once two year olds with FEET funding are placed on roll at nursery, they will be automatically entitled to take up a three year old place in our nursery. If your two year old does not have FEET funding then you must apply for a three year old place.

Nursery Sessions (including payment)

- 30 hours - all day Monday to Friday (8:45am - 2:45pm)
- 15 hours - all day Monday and Tuesday (8:45am - 2:45pm), plus Wednesday morning (8:45am - 11:45am)
- 15 hours - Wednesday afternoon (11:45am - 2:45pm), all day Thursday and all day Friday (8:45am - 2:45pm)

Parents may pay for an additional 30 minutes from 2:45pm to 3:15pm at a cost of £3 per day (Monday, Tuesday, Thursday and Friday). If you purchase at least two days additional 30 minutes, then Wednesday is free.

Nursery children may bring a packed lunch or purchase school meals at a cost of £2.25 per day.

We only offer either two and a half days or five full days. We expect a good record of attendance. If it falls below 90% you will be invited to a meeting with either the class teacher or head teacher. If attendance does not improve then you may forfeit your place. The head teacher's decision is final in all matters.

The school will inform parents of the outcome of their application by letter. If a parent is offered a place they must confirm acceptance directly with the school by the date stipulated in their offer letter.

The final decision with regard to admission and the allocation of sessions will rest with the Governing Body of the school.

Where the nursery is oversubscribed it will operate a waiting list based on the oversubscription criteria without regard to the date the application was received or when a child's name was added to the waiting list.

Admission for Reception

Admission to the school's nursery does not guarantee admission to the Reception class.

Application for Reception must be made on a separate application and be submitted by the statutory deadline in order to be considered.
